**Official Rules** 

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

INTERNET ACCESS AND VALID E-MAIL ADDRESS REQUIRED.

1. ELIGIBILITY. The "Blueprint MCAT \$20,000 Med School Scholarship Giveaway" (the "Sweepstakes") is only open to entrants who, as of the date of entry: i) are permanent legal residents of the fifty (50) United States of America, the District of Columbia or Puerto Rico, at least eighteen (18) years old or age of majority in his/her state of residence, and ii) will be taking the MCAT during the timeframe of January 1, 2024 to September 30, 2024 and intend to apply to an LCME-accredited allopathic medical school or COCA-accredited osteopathic medical schools for matriculation (i.e., beginning of studies) as a first-time medical student no earlier than July 1, 2025 and no later than October 1, 2026. The foregoing requirements are referred to in these Official Rules as the "General Eligibility Requirements."

An entrant must satisfy all of the General Eligibility Requirements in order to participate in the Sweepstakes and to win the General Prize (as defined and described in Section 6 below) drawing.

The Sweepstakes is void outside the fifty (50) United States of America, the District of Columbia and Puerto Rico; and where prohibited or restricted by law. Employees, officers and directors of Blueprint Test Preparation LLC. ("Sponsor"), and its parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and National Sweepstakes Company, LLC ("Administrator") and the immediate families (defined as parents, spouses, children, grandchildren, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. 2. TIMING; ENTRY PERIODS. The winner will be selected in a random drawing to be held on or about November 20, 2023 ("Drawing Date."). Sponsor's computer is the official timekeeping device for the Sweepstakes.

## 3. HOW TO ENTER.

TO ENTER: During the Entry Period, visit Sponsor's website located at <u>https://</u> <u>blueprintprep.com/mcat/med-school-scholarship</u>, and fully complete and submit the Sweepstakes entry form. The Sweepstakes may also be accessible directly from a particular URL.

LIMIT: No more than one (1) entry per person. All entries become the exclusive property of Sponsor and will not be returned. Receipt of entries may I be acknowledged, but any such acknowledgment is in no way binding upon Sponsor or Administrator. Proof of submission will not be deemed to be proof of receipt or proof of entry by Sponsor or Administrator. Entrant subject to verification by a notarized Affidavit of Eligibility, a Liability Release, and, except where prohibited by law, a Publicity Release (an "Affidavit/Release"), as described herein, prior to the awarding of the prize, including eligibility, age and other claims of/information provided by potential prize winner. Entrants agree to cooperate with Sponsor and its representatives (including Administrator) in connection with any and all verification activities (as applicable). 5. DRAWING; ODDS; NOTIFICATION. There will be a total of one (1) drawing in the Sweepstakes. On or about November 20, 2023, Administrator will randomly select one (1) potential General Prize winner from among all applicable entries received. Odds of winning the General Prize depend on the number of eligible entries received. If selected, entrant must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Potential winner will be notified by phone and/or email using the contact information provided by an entrant in the entrant's online Sweepstakes entry form. A potential winner will be required to execute and return to Sponsor an Affidavit/Release in order to claim the prize. The Affidavit/Release must be returned to Sponsor by the date and/or time indicated within the Affidavit/Release. If potential winner (A) cannot be contacted directly by Sponsor within seventy-two (72) hours of the first attempt to contact him/her, (B) fails to return the Affidavit/Release within the specified time, or (C) is found to be ineligible, or if potential winner does not comply with the Official Rules, or if prize or prize notification is returned as undeliverable, then the potential winner may be disgualified and an alternate winner selected by Sponsor/Administrator in his/her place at random from among all remaining eligible non-winning entries received. ## 6. PRIZE.

a. GENERALLY, The "General Prize" (also referred to as the "Grand Prize") to be awarded in this Sweepstakes is a scholarship for \$20,000USD to be applied towards medical school tuition (value of twenty thousand dollars (\$20,000USD).

b. GENERAL PRIZE. The Grand Prize consists of and is limited to one (1) "Scholarship" to be applied towards tuition at a medical school (up to twenty thousand dollars (\$20,000USD) payable to a post-undergraduate LCME-accredited allopathic medical school or COCA-accredited osteopathic medical school institution, as described in more detail in Section 6(c) below, Total Value of the Grand Prize is twenty thousand dollars (\$20,000USD).

c. SCHOLARSHIP. The Scholarship to be awarded in this Sweepstakes consists of and is limited to one (1) scholarship of \$20,000USD towards tuition to attend any post-undergraduate Liaison Committee on Medical Education (LCME)-accredited allopathic medical school or American Osteopathic Association's Commission on Osteopathic College Accreditation (COCA) -accredited osteopathic medical school, including schools located domestically or internationally (an "Eligible Institution"), for first time medical students with attendance to begin no earlier than July 1, 2025 and no later than October 1, 2026. The Scholarship will be available to be paid only during the prize winner's first three years of attendance at an Eligible Institution, commencing at the start of the winner's enrollment at Eligible Institution. Scholarship must be used only for tuition and expressly excludes all other expenses in conjunction with attendance at an Eligible Institution (such as, room, board and books). Scholarship funds will be paid directly to the Eligible Institution and not the prize winner; scholarship funds will be released to the Eligible Institution only after winner's provision of satisfactory proof of enrollment at Eligible Institution from the bursar or other administrative office at Eligible Institution. The Scholarship is not renewable and is good for three years from the date of enrollment. If prize winner does not enroll in and commence classes at an Eligible Institution by October 1, 2026, the prize will be forfeited, in which case, no consideration will be paid to the Eligible Institution for the benefit of the prize winner. If prize winner timely enrolls and commences classes at an Eligible Institution but his/her tuition for the quarter/semester is already funded for the first quarter/semester (e.g., from another scholarship), the Scholarship will be awarded for first guarter/semester after such alternate source of tuition funding has been exhausted and will only be available for three years from enrollment. However, if prize winner's entire medical school education in pursuit of an MD or DO degree is already funded, the prize will be forfeited without compensation of any kind. If prize winner enrolls and commences taking classes but then withdraws from attendance at Eligible Institution prior to the conclusion of the quarter/semester, Sponsor will seek a refund of the scholarship funds paid by it; and, to the extent Sponsor is able to recoup scholarship funds paid, winner will not receive same or any other compensation/prize. Should prize winner transfer to another Eligible Institution after enrolling and commencing taking classes at a given Eligible Institution, Sponsor will provide scholarship funds to the Eligible Institution to which prize winner transferred only to the extent that Sponsor was able to secure a refund of the scholarship funds from the Eligible Institution where prize winner originally enrolled and commenced taking classes.

d. LIMITATION ON PRIZE. The Prize is nontransferable, nonassignable, nonnegotiable, and not redeemable for cash or credit. The prize must be accepted as awarded, "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by Sponsor or for which Sponsor shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. Unused scholarship funds shall be forfeited, and no unredeemed scholarship funds will be paid to the prize winner or to the Eligible Institution. Winner is solely and fully responsible for any and all costs, fees, taxes, assessments and expenses associated with prize award, redemption, receipt and use, including, without limitation, all federal, state and local taxes on the prize. Winner will be issued an IRS Form 1099 for the actual retail value of the prize. Winner waives the right to assert as a cost of winning prize any and all costs of verification and redemption or travel to redeem the prize. Noncompliance with any of the foregoing and any other condition of

this Sweepstakes may result in disqualification and forfeiture of prize, in which case, no consideration will be awarded.

7. PUBLICITY.
